Investment Criteria	Real estate and land developing - The investor should have a direct investment in Cyprus of min €300,000 (excl. VAT) for the purpose of acquisition or development of new real estate projects (residential, commercial, tourism sector or other infrastructure). Additionally
	Hold three years deposit €30,000 with a Cypriot bank and must demonstrate annual income €30,000 €5,000 income for each of the dependent children and €8,000 income per dependant parent annually
Timeline	3-4 months



Key details of Cyprus Citizenship by Investment

Investment Criteria	Real estate and land developing - The investor should have a direct investment in Cyprus of min €2.0 million (excl. VAT) for the purpose of acquisition or development of real estate projects (residential, commercial, tourism sector or other infrastructure).
	Purchase or participation in Cypriot businesses or companies - The investor must have made an investment of at least €2.0 million (excl. VAT) in the purchase or participation in businesses or companies, that are based and operating in Cyprus.
	Investment in AIFs or financial assets of Cypriot businesses or organizations - The applicant must have purchased financial assets of at least €2.0 million (excl. VAT), i.e., units in Alternative Investments Funds, bonds, debentures, other securities, etc., Additionally
	Own a permanent residence in Cyprus of a market value of at least €500.000 (excl. VAT).
Lock-in-Period	The investor is obliged to retain the investment for at least 3 years following the acquisition of the Cyprus citizenship but must retain possession of a permanent residence of at least €500.000 (excl. VAT) for life.
Timeline	3-4 months

Benefits of Cyprus Investment Programmes

- No requirement to reside in Cyprus after obtaining the Cyprus passport
- The investment can be as low as €300,000 (if the investment is solely in residential property), in Permanent Residency by Investment programme
- Access to all rights of an EU citizen protected by EU legislation and regulations, i.e. freedom to work, study, reside in any EU member state, as well as Switzerland, Norway, Iceland, Liechtenstein
- Dual-citizenship permitted and the acquisition of citizenship in Cyprus is not reported to other countries

- An express procedure in obtaining an EU passport
- The investment can be as low as €2.0 million (if the investment is solely in residential property) in Citizenship by Investment programme. No language proficiency tests
- Citizenship / Residency is granted to the parents, spouse and dependent children under the age of 25 of the investor
- The investor must retain the investment for only 3 years after which she/he is free to realize it
