About Grenada CBI

Applications for this program are sent to the Grenada Citizenship by Investment Committee. The program is controlled by the Grenada Citizenship by Investment Act 15 of 2013. The minimum investment for Grenada's Citizenship by Investment Program is US \$235,000. Grenadian people have visa-free entry to 144 destinations, including the Schengen Area, China, Russia, and the United Kingdom. Furthermore, Grenada is the only Caribbean CBI country having an active E-2 Treaty with the United States, which allows its people to apply for U.S. E-2 investor visas.

Eligibility

- Minimum age: 18 years.
- Must pass a medical exam and be free of contagious diseases.
- Provide police clearance and proof of legitimate investment funds.
- Pass background checks, attend online interview, and pay mandatory fees.
- No travel or residency in Grenada is required.

Investment Options

Investors can contribute to the National Transformation Fund (NTF) or invest in an Approved Real Estate Project.

1. National Transformation Fund (NTF) contribution option

Family of up to four: US\$235,000.

Additional dependents: US\$25,000 for children, parents, or grandparents over the age of 55.

Dependent parents or grandparents under the age of 55: US \$50,000

Dependent siblings: US\$75,000.

2. Approved Real Estate Investment Projects Option

Family of up to four - US\$270,000.

Process

1

Choose between a US\$235,000 NTF donation and US\$270,000 in authorized real estate.

2

Prepare the following documents: passport, birth certificate, medical report, police clearance, and financial proofs.

3

Complete due diligence and an online interview for applicants above the age of 17.

4

Receive approval and make the necessary investment within 30 days.

5

Grenada passports are issued following investment verification and an oath of allegiance.

6

Maintain a real estate investment for five years (assuming you choose the property option).

7
